Terms & Conditions:

LOW / MID / HIGH SEASON

- Deposits (minimum of one nights stay) are payable within 7 days of making the reservation.
- Reservations are only confirmed on receipt of deposit.
- The balance of the reservation is payable in full on arrival.
- Sites are allotted at the discretion of management who reserve the right to alter if necessary or cancel tenancy at any time.
- Minimum stay periods apply in public & school holidays. Refer above.

Cancellations

- Cancellations or alterations made for any reason will incur a \$20 administration fee.
- Cancellations with less than 24hours notice will result in loss of deposit.

Alterations

- Alterations can be made subject to availability and may require a site change. Management reserve the right to cancel a reservation if the alteration reduces the reservation to below minimum stay requirements and cancellation penalties will apply.
- Alterations to the number of guests requires management approval.
- No refund will be made should guests alter or leave before their reserved departure date.

Damages

PEAK SEASON

- All Peak Season reservations have a \$50 non-refundable booking administration fee which is credited to the reservation upon settlement of the account.
